DECLARATION OF ESTIMATED APPLE CREEK, OHIO, INCOME TAX

General Instructions

This form for use by (1) businesses filing 20 declarations, and (2) businesses wishing to amend their 20 estimates.

1. PURPOSE OF DECLARATION ---A declaration for Apple Creek Income Tax purposes must be made by every business receiving income subject to Apple Creek, Ohio, Village Income Tax.

The purpose of the declaration is to provide a basis for paying currently any Apple Creek Income Taxes due.

2. FORM TO BE USED---This Declaration should be used by businesses on a calendar year basis to estimate their tax covering the period from January 1, 20 to December 31, 20

3. WHEN TO FILE DECLARATIONS---The Declaration must be filed on or before April 15, 20 , if taxpayer is on a CALENDAR year basis, or within 31/2 months after the beginning of taxpayer's fiscal year.

Complete information regarding Apple Creek Income Tax may be obtained from booklet "Apple Creek Income Tax Regulations," available on request.
